What a Difference a Year Makes



MY END-OF-YEAR REFLECTION ALWAYS INCLUDES a review of what I wrote for this column last year. What a difference a year makes.

On track

The cooperative's plans and projects remain on track with several reaching their final stretch in the upcoming year. This work can be categorized into our longer-term cycle work and our shorter-term goals, which stem from our strategic planning session. Our 2022 planning session had a three-to-five-year implementation plan, so this year we focused on designing and building the foundation for these initiatives.

Our most significant progress came from the expansion of our metering infrastructure and the development of tools to proactively use our metering data. Thousands of updated meters have been installed. These meters will provide real-time information that can improve our operational decisions for upgrading equipment, coordinating outages and planning for future expansion.

Our broadband support project, which helped about 125 members explore their internet options, will end this month. Members involved in this project have offered positive feedback and most have found a suitable option to provide some form of internet service. The rapidly changing nature of this technology will likely result in different options and different needs for our members. While this step of the process is ending, we will remain engaged on this topic and may launch similar efforts in the future.

Electricity markets and supply chains

Electricity production and consumption have changed significantly in recent years. Pairing these changes with the disruptions in global energy markets created major volatility for electricity prices. Some of this volatility seems to have subsided, but the demand for electricity continues to rise. Part of this increase was built into our recent rate changes, and we will continue to update you as we know more about how energy prices evolve in the near future.

Good news continues for our supply chains. While many manufacturers have changed the way they do business, the lead times for many common components have become predictable. Hopefully, these lead times will soon return to their former patterns and allow us to manage our inventory more efficiently.

Optimism

In last December's column, I said the biggest surprise of 2023 was that pessimism had crept into many conversations I had. The most welcome change I can report for 2024 is that optimism has returned to many of those conversations. It was hard for me to point to something specific that caused last year's attitude, but clearly many of those feelings have been replaced with a renewed sense of hope. Hopefully, we will all focus on what we can control in our daily lives to ensure these feelings remain.

I hope the holidays give you a chance to be surrounded by friends and family. Merry Christmas and Happy New Year. 2

A Credit Instead of Coal

AT THE CO-OP, AS WE make our list and check it twice, members who lived on cooperative lines in 1999 and 2000 will receive an electric bill credit this month — whether they've been naughty or nice. As a cooperative member, you deserve a credit for helping build and sustain your local electric cooperative. This month, Somerset Rural Electric Cooperative (REC) returned \$571,000 to members across our co-op service territory.

When you signed up to receive electric service from Somerset REC, you became a member — and owner — of an electric utility. While investor-owned utilities return a portion of any profits back to their shareholders, electric co-ops operate on a not-for-profit basis. Instead of returning leftover funds, known as margins, to investors who might not live in the same region or even the same



state as you do, every December, we issue capital credits based on how much you paid the co-op for electricity during a specific period.

If you were a Somerset REC member in 1999 or 2000, you should have noticed a credit on your electric bill this month. Members from that period who no longer live in the cooperative's service territory received a check in the mail. This reflects your ownership of the cooperative. During



those years, Somerset REC saved part of what was paid by the members to cover emergency expenses and to build and maintain a reliable electric delivery system.

If you were a recipient, we hope you enjoyed the extra jingle sent your way this holiday season — although a lump of coal doesn't sound too bad when you're an adult.

If you established a membership after 2000 and are wondering when you will receive capital credits, the current capital credits payback timeframe is 23 to 25 years.
