### HVAC Equipment Terms and Conditions

1. New equipment and services must be purchased and installed between January 1 - December 31 of the rebate program year. Rebate application must be submitted by January 31 of the following calendar year. Must submit one rebate application form per unit.
2. Applicant must be a Somerset Rural Electric Cooperative, Inc. residential member.
3. Equipment must meet the standards defined on page 2 of this rebate application form. Both the condenser and coil/indoor unit must be replaced and installed as a matched set as defined by AHRI.
4. The efficiency levels are based on the Air-conditioning, Heating, Refrigeration Institute (AHRI) certified performance criteria of an outdoor unit and indoor coil (and/or furnace/blower) working together. These ratings are found on the AHRI directory.org website. All ENERGY STAR-certified equipment must be listed at energystar.gov in order to participate in this program. Both the outdoor unit and coil /indoor unit must be replaced and installed as a matched set.
5. By submitting this rebate application, you acknowledge Somerset Rural Electric Cooperative, Inc. reserves the right to review installations at a time convenient to a Somerset REC employee.
6. Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
7. Payment will be issued to the account holder at mailing address listed on rebate form.
8. Please allow up to 90 days from the date all required information is received to process your rebate.
9. It is the responsibility of the applicant to seek appropriate consultation concerning any tax liabilities that could be associated with the receipt of the rebate.
10. Somerset Rural Electric Cooperative, Inc. assumes no responsibility for the performance of the equipment or equipment warranty, the quality of the work, labor and/or materials supplied, and/or the acts or omissions of the contractor.
